Working together to apply the responsibility to protect

The Security Council,

*Reaffirming* the Universal Declaration of Human Rights adopted by the General Assembly of the United Nations on the 10th of December of 1948 proclaiming “Everyone is entitled to all the rights and freedoms set forth in this Declaration, without distinction of any kind, such as race, color, sex, language, religion, political or other opinions, national or social origin, property, birth or another status.”,

*Thanking* the progress the world has made towards the respect of all since the adoption of this declaration as well as the countries that are still trying to research a perfection of equality in their territories, and encouraging a deeper analysis of the application of our noble principles in all the countries, we, as the peoples of the United Nations, are willing to act responsibly,

*Deeply* conscious of the numerous populations coexisting in the world, and to assure a peaceful cohabitation of all, we must define what is a minority, and that is to say individuals in numeral inferiority on a given territory in comparison with the total population or the majority group, and considered as having a non-dominant position inside the State as well as ethnic, linguistic or religious common characteristics and being citizens of the State, according to Francesco Capotorti, Special Rapporteur of the Sub-Commission on Prevention of Discrimination and Protection of Minorities in 1979,

*Having* devoted attention to the minorities present in our country founded by the merging of ethnicities, the minorities present in the United States of America are 16% Hispanics, African-Americans and black people representing 13%, 5% Asian, as well as 1.5% native American and autochthonal populations of Alaska, and 18.5% disabled persons. Therefore, to fulfill our duty as a sovereign nation to provide security and equality for all, we make a statement,

*Alarmed* by the great danger minorities are facing in the world and the reality of the unjustifiable treatment they receive, including discrimination, violence, torture, mass sexual abuse, forced sterilization, injustice, the annihilation of their culture, repression of the minorities expressing using their human rights, we seek to finally put an end to this paradigm,

*Expressing* its will to protect the whole of humanity by assuring “the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice, and peace in the world”, and, for these specific purposes, the Security Council acting under Chapter V of the Charter of the United Nation,

1. *Invites* the members of the Security Council to meet to reach an agreement on the measures that must be taken for the protection of minorities because it is an emergency that can not be pushed back, and reminds them to act according to the international laws in effect concerning the minorities, and respect their rights like any other human being deserves;

2. *Condemns* any creation of a discriminatory law in a State, no such law should be allowed, a country which disobeys this order must be penalized by a fine that should be discussed within the Security Council;

3. *Suggests* to discourage acts of hate directed towards minorities by taking measures of dissuasion, such as creating penalties to ensure that the population as well as the government recognize the minority and does not support acts of differentiation indeed the whole population must benefit from the same rights;

a) *Encourages* governments to remove from their duty any government official whose acts are discriminating a minority, including justice representatives whose acts are biased by a racist mindset, as well as police officers who abuse of their power to satisfy a personal racist and discriminant ideology;

b) *Strongly condemns* any act of psychological or physical abuse on a member of a minority or a group, including the will to erase their culture or forcefully convert them into the ideology of the country, the violation of these terms must be severely punished, economical penalty, as well as the refusal of having any economical trade with the country may therefore be applied, and for the instigators of the action they will be judged by the national justice court or international instances depending on the scale;

4. *Supports* initiatives permeating the education of minorities as well as the education of the dominant population about the minorities present in their country and worldwide, it prevents actual and future discrimination, funds could be given if necessary;

5. *Emphasizes* the needs of medical access of these minorities and forbid any distinction made in the medical treatment suggested by the medical personnel, the personnel guilty of the discrimination and mistreatment of the person must be judged in the country for its act;

6. *Encourages* the spread of these initiatives among all countries, and moving towards the complete acceptance of these disabilities with the adaptations that come along the way of giving them the same opportunities as non-disabled person, likewise funds could be given if necessary, these funds would be collected by the United Nations in the United States of America through campaigns, the countries which make a demand may have their case analyzed and an adequate part of the budget would be given;

7. *Endorses* the declarations previously made, and if it comes the minority is attacked by the very same State they are living in, or another State, arms shipment must be considered for the minority to defend themselves from the unjustified attacks made by countries which do not respect inalienable human rights;

8. *Trusts* the ability of each State to apply this resolution, and believing they will take the responsibility of their sovereignty over minorities included rightfully in their country, helping the cohesion of all the populations and the development of the country;
